## Suspension, Negotiated Transfer and Expulsion of Students Framework

## Advice to principals regarding new MACS board-approved policies and forms – 11 July 2022



The MACS board and executive director have approved the Suspension, Negotiated Transfer and Expulsion of Students Framework including guidelines, policies, templates, procedures and forms.

Principals should note or action the following:

- all board-approved policies and associated documents are labelled v[version number].0 [year of approval], e.g. v2.0 2022
- the current approved policy version must be used by schools/colleges and published on the school/college website where indicated
- policies/documents must be contextualised by the school/college where indicated
- principals are to ensure all school staff are aware of the new guidelines and policies
- required actions must be completed by Friday 5 August 2022.
